

IMPORTANT THINGS TO KNOW

This document provides a summary of important information regarding your cruise vacation. A more detailed description of terms and conditions can be found in the Princess Cruises' brochure. Should you have any questions, please contact Magic Cruises & Tours (MAGIC).

Payment Requirements: Accommodations in each category at the discount rates are limited and subject to availability. Reservations are made on a first-come, first-served basis, while supply lasts. **Deposit:** Princess Cruises normally requires 20% of the cruise tour fare to confirm a reservation. Various promotional opportunities may apply. MAGIC will always try to get you the best value you qualify for!

Final Payment: The balance is due in full no later than June . Additional payments are accepted at anytime until final payment. Cruise payments in U.S. Dollars can be made by check or credit card. We accept VISA, MasterCard, American Express and Discover. Discounted group rates may not be combinable with other discounts or coupons.

Cruise Cancellations: The penalty periods/cancellation fees:

<u>Cancellation Guidelines</u>	<u>Cancellation Fee</u>
Outside of 76 days prior to departure	\$25 per person
Between 75-57 days prior.....	20% of total price (per person)
Between 56-29 days prior.....	50% of total price (per person)
Between 28-15 days prior.....	75% of total price (per person)
Within 14 days prior	100% of total price

Princess considers the day prior to the departure date as the first day. You must contact us by 5:00pm EST the day before the penalty period begins to avoid the fee. Travel insurance may also protect you against cancellation fees.

Proof of Citizenship: All passengers must carry proof of citizenship in the form of a valid passport book OR a notarized birth certificate and government issued Driver's License, in accordance with government requirements at the time of travel. Passports should be valid for at least 6 months beyond travel dates. It is the responsibility of all non-U.S. citizens to check with the local immigration office, embassy, or consulate to determine documentary requirements. There is no refund if a passenger is denied boarding the ship for lack of proper documents.

Travel Arrangements/Transfers: MAGIC will assist you with flight options/arrangements for this cruise. Schedules will start to become available in October, 2017. Flights should arrive into Seattle August 17 or no later than Noon on August 18. Flights should depart Seattle on August 25 after 11:30am. Roundtrip transfers between airport/ship with Princess Cruises may be added to your reservation at \$58 per person.

Pre & Post-Cruise Hotel Packages: We recommend guests to arrive in Seattle 8/17, to avoid concerns about travel delays. Information regarding hotel options will be communicated in October, 2017.

Travel Documents: Guests are required to complete the Passenger Immigration information online at www.princesscruises.com (under "Booked Passenger" and "Cruise Personalizer") prior to tickets being issued. Electronic travel documents may be accessed on your Cruise Personalizer, MAGIC will communicate instructions approximately 3 weeks prior to departure.

Optional Excursions: Princess Cruises offers a wide variety of optional tours in each port of call to enhance your experience. Typically, these tours can be reviewed and ordered online under the "Cruise Personalizer" approximately 6 months prior to travel.

Not Included: Items not part of the cruise vacation price include (but are not limited to): optional tours, wines/liquor/soft drinks, shipboard personnel gratuities, gambling, laundry and items of a personal nature. Princess Cruises reserves the right to reinstate a fuel surcharge.

Smoking Policy: Princess prohibits smoking in staterooms and balconies. Designated smoking areas are available.

Guests with Special Needs: Princess requires notification of any special medical, physical (including pregnancy) or other requirements of passengers at the time of booking. Please inform Magic Cruises of any special needs when making your reservations.

Travel Insurance: We recommend the purchase of comprehensive travel insurance to protect yourself and your investment in case the unexpected does occur. Travel insurance provides coverage for such events as trip cancellation, interruption, damaged baggage, and medical expenses. Princess Cruises offers Standard and Platinum travel protection. MAGIC offers Allianz Global Assistance Horizon Plan that is priced at 6.5% of your total trip cost. Some restrictions and limitations do apply. Please contact MAGIC for details before final payment (deadline to purchase coverage is at the time of final payment).

MAGIC neither controls, nor operates, nor accepts responsibility for any accidents, illnesses, damages, baggage losses, delays, or defaults of any company used in the operation of this tour.
