



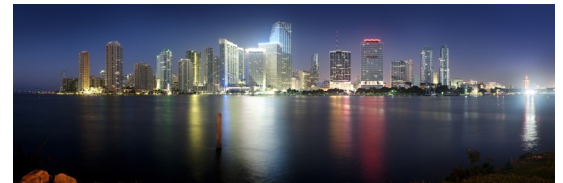

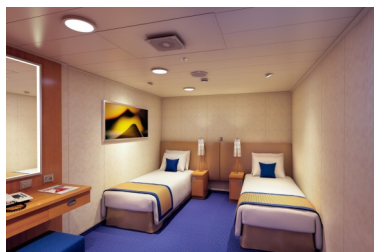
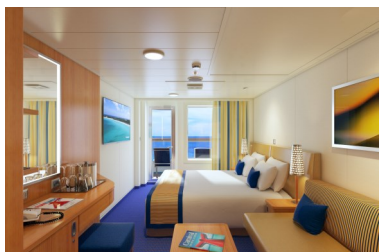

# THINGS TO KNOW

This document provides a summary of important information regarding your cruise vacation. A more detailed description of terms and conditions can be found in the Carnival Cruise Lines brochure. Should you have any questions, please contact Magic Cruises & Tours.

**Payment Requirements:** A deposit of \$250 per person is required to secure your reservation. Reservations are made on a first-come first-served basis and are subject to availability. Final payment is due no later than May 1, 2018. Additional payments are accepted at anytime until final payment. Payments can be made by cash, money order, check or credit card. We accept VISA, MasterCard, Discover, or American Express. Group rates might not be combinable with other discounts or coupons.

**Cancellations:** There is a \$25.00 per person administrative fee for all cancellations. In addition, Carnival charges a cancellation fee if the cancellation occurs during a penalty period. The penalty periods and cancellation fees are as follows:

| <b>Prior to Departure Date</b> | <b>Cancellation Fee</b> |

| Before May 1, 2018             | None                    |
| May 2 - June 3, 2018           | \$250 per person        |
| June 4 - June 30, 2018         | 50% of total price      |
| July 1- July 14, 2018          | 75% per person          |
| July 15 or closer              | Full penalty            |

Carnival Cruise Lines considers the day prior to the departure date as the first day. You must contact us by 5:00pm EST the day before the penalty period begins to avoid the fee. Travel insurance (see next section) may also protect you against these cancellation fees.

**Travel Insurance:** We recommend the purchase of comprehensive travel insurance to protect you in case the unexpected does occur. Travel insurance provides coverage for such events as trip cancellation, interruption, damaged baggage, and medical expenses. Some restrictions and limitations do apply. The cost of Carnival's Vacation Protection varies based on cruise cost but is approximately \$95—\$149 per person. Magic Cruises & Tours also offers travel insurance through Allianz Global Assistance - Horizon Plan. The premium for this plan is 6.5% of trip cost. Insurance must be purchased or declined before the final payment date. Call for details.

**Travel Documents:** All U.S. citizens must carry with them a valid passport book valid for at least six months beyond the travel dates or other proof of citizenship. Non U.S. citizens should contact Magic Cruises & Tours. It is the responsibility of all Non U.S. citizens to check with the local immigration office, embassy, or consulate to determine documentary requirements. There is no refund if a passenger is denied boarding the ship for lack of proper documents.

**Not Included:** Items not part of the cruise vacation price include (but are not limited to): optional shore tours, wines/liquor/soft drinks, gratuities gambling, laundry and items of a personal nature.

**Guests with Special Needs:** Carnival Cruise Lines requires notification of any special medical, physical (including pregnancy) or other requirements of passengers at the time of booking. Please inform Magic Cruises & Tours of any special needs when making your reservations.
