

## IMPORTANT THINGS TO KNOW

This document provides a summary of important information regarding your cruise vacation. A more detailed description of terms and conditions can be found in the Princess Cruises' brochure. Should you have any questions, please contact Magic Cruises & Tours (MAGIC).

**Payment Requirements:** Accommodations in each category at the discount rates are limited and subject to availability. Reservations are made on a first-come, first-served basis, while supply lasts. **Deposit:** Princess typically requires 20% of the cruise fare to confirm a reservation. Some promotions may allow for a reduced deposit. **Final Payment:** The balance is due in full no later than October 1, 2019. Additional payments are accepted at anytime until final payment. Cruise payments in U.S. Dollars can be made by check or credit card. We accept VISA, MasterCard, and Discover. Discounted group rates may not be combinable with other discounts or coupons

Princess considers the day prior to the departure date as the first day. You must contact MAGIC by 5:00pm EST the business day before the penalty period begins to avoid the fee. Travel insurance may also protect you against these cancellation fees.

**Airfare:** Airfare payments and cancellation fees are subject to separate terms and conditions (typically flights are non-refundable). Princess Cruises EZ Air and other independent flights will be available to book starting about 11 months prior to sailing dates. Ask for assistance.

**Travel Insurance:** Policies are available for purchase to protect you in case the unexpected does occur. Travel insurance provides coverage for such events as trip cancellation, interruption, damaged baggage, and medical expenses. Allianz Global Assistance Horizon Plan is available to US residents to purchase at a cost of 7.25% of total trip cost and must be purchased no later than final payment. Princess Vacation Protection and other Insurance alternatives are available to US or Canadian residents. Some restrictions and limitations do apply. Please contact MAGIC for details.

**Proof of Citizenship:** All passengers must carry with them proof of citizenship. For US citizens a valid passport book is recommended. Passports should be valid for at least 6 months beyond travel dates. It is the responsibility of all non-U.S. citizens to check with the local immigration office, embassy, or consulate to determine documentary requirements. There is no refund if a passenger is denied boarding the ship for lack of proper documents. In lieu of a passport US citizens may bring a valid government issued photo ID along with a certified copy of a matching birth certificate (a marriage certificate required if name is different than birth certificate).

**Travel Arrangements/Transfers:** If you are making your own flight arrangements, please plan to arrive into Ft. Lauderdale airport (FLL) no later than 2:30 PM on January 18 and depart after 11:30 AM on January 25. If you are flying into Miami (MIA) plan to arrive by 1:30 PM and depart after 1:30 PM. Airport transfers may be added to your reservation at a cost of \$19 pp each way from FLL and \$29 pp each way from MIA Call MAGIC for assistance.

**Pre & Post-Cruise Hotel Packages:** Princess Cruises offers hotel packages in Ft. Lauderdale in conjunction with your vacation. Please ask for details when making reservations as space is subject to availability. It is highly recommended to add day prior to the sailing to allow for travel delays.

**Travel Documents:** Guests are required to complete the Passenger Immigration information online at [www.princesscruises.com](http://www.princesscruises.com) (under "Booked Passenger" and "Cruise Personalizer") prior to final payment. Detailed instructions will be mailed to you once you book your cruise.

**Optional Excursions:** Princess Cruises offers a wide variety of optional tours to enhance your experience. Typically, these tours can be reviewed and purchased online under the "Cruise Personalizer" approximately 6-9 months prior to travel.

**Not Included:** Items not part of the cruise vacation price include (but are not limited to): shipboard gratuities, travel insurance, optional tours, wines/liquor/soft drinks, gambling, laundry and items of a personal nature. Princess Cruises reserves the right to reinstate a fuel surcharge.

**Smoking Policy:** Princess prohibits smoking in staterooms and balconies. Designated smoking areas are available.

**Guests with Special Needs:** Princess requires notification of any special medical, physical (including pregnancy) or other requirements of passengers at the time of booking. Please inform Magic Cruises of any special needs when making your reservations.

At time of printing: All information is known to be accurate based on the details available at time of printing. Certain aspects may change slightly given the length of time from promotion to trip departure. Booked guests will be notified in the event a change has occurred that impacts them.
